

ALL CLUBS' PRH MUST DO ACTIONS 2017

(Supplement to Report on 2016 Club Development Forum)

Clubs are required **BY LAW** as well as a **condition of FCA Membership** to run as 'ry' associations registered with the PRH. Only 2 of the 16 league playing FCA clubs updated the PRH in 2016. **All others are presumed to be out of date**, 7 are known to be so. 10 league clubs failed to run a proper AGM to the legally required Agenda and 10 need to improve the quality and content of their AGM Minutes (see 2016 Report in full).
